DISTRICT COVERAGE

- Cesar noted that there wasn't any income from billable calls
- Neighboring Fire had nearly 400 calls. A lot of them were alarm calls.
- Paid staff is still alternating weekends. Seems to be working out. It helps fulltimers to feel like they have a tiny bit of leeway to do something on the weekends.
- An incident commander is assigned when we get to calls

OLD BUSINESS

- VFIS there should be a decision tonight.
 - Tucker felt that the increased deductibles were substantial. \$100 to \$1000 is a large window.
 - If we accept the bid as it is without high deductibles we will still be within our budget.
 - The bid brought the truck values up to where they should be.
- After the discussion, the Board is in agreement to accept the proposal without changing the deductible.

A MOTION THAT THE DISTRICT ACCEPT THE VOLUNTEER FIRE INSURANCE PROPOSAL FROM VFIS WITH THE NEW VALUATIONS FOR THE TRUCK AND EQUIPMENT AND LEAVE THE DEDUCTIBLE AT \$100 FOR THE PORTABLE PROPERTY AND \$1000 FOR THE BUILDING AND AUTHORIZE THE CHAIR TO SIGN THE AUTHORIZATION IF A SIGNATURE IS NEEDED, WAS MADE BY HASSLER. SECONDED BY WHITE. MOTION CARRIED.

- Station Two Lease Discussion
 - The Board took the time to discuss the lease agreement.
 - We are paying utilities up there 12 months a year and the county reimburses us for the winter months that they use
 - O It was suggested that our Board present an amount to the Grand County Commissioners and ask them to buy the building. The potential market value low is in the \$400,000's high is \$600,000's.
 - If we sell it we should invest it in something to benefit the District.
 - We could state what the funds from the sale would be used for.
 - Eggers will talk to one of the Commissioners to see what their interest level is.
