BOARD OF DIRECTORS WORK SESSION REVIEW

- The Board went through the SDA boilerplate bylaws and customized it for their own. Another workshop is
 in order to complete the corrections so we can adopt them. The District Administrator title needs to be
 plugged into the final copy.
- Where the document refers to manager the Board will use the term Fire Chief.
- Policy manual covers fire operations, bylaws cover governing laws.
- The Board would like to set a Board workshop for August 22, 2024 6:00 PM to review the Board of Directors Bylaws.

DISTRICT COVERAGE

- At the worksession they discussed the mail survey. There was some confusion if the survey was about volunteers or about taxes.
- A question was asked what exactly Aron is working on pertaining to recruitment. The board would like Tucker and Mathis to give a report each month what recruitment avenues Aron is working on. That way there would be an ongoing discussion of where the recruitment process is. Cesar stated that there needs to be cohesiveness in recruitment efforts so the Board and Aron can work in conjunction with one another and not duplicate or reinvent the wheel.
- The Board discussed in the workshop that maybe a cadet program directed at 18-21 year olds should be considered. Tucker said that the staff will discuss that. Eggers said that maybe KFPD could be a training program for firefighters that want to move to paid departments. Tucker stated that cadets are limited to the scope of work they can do because of age.
- Carland stated that the past cadet programs have produced great results with some people getting hired on to fire
 jobs.
- Tucker said that recruitment is discussed daily amongst the paid staff.
